Application for Membership – Notes for Guidance

1. Membership

- 1.1 The membership of the Club shall consist of:
 - 1.1.1 Adult Members (Aged between 26 and 66 years)
 - 1.1.2 Senior Members (Aged 67 years or over)
 - 1.1.3 Junior Members (Aged 17 years or under)
 - 1.1.4 Youth Members (Aged between 18 and 25 years)
 - 1.1.5 Overseas/Country Members
 - 1.1.6 Social Members
 - 1.1.7 Family Members

All ages shown are those applying on 1st February of each year or on the date of application if later.

- 1.2 All members, other than Honorary Members, shall pay an annual subscription to the Club; the subscription for each category of membership shall be decided by the members at the Annual General Meeting each year.
- 1.3 Family Membership may be granted to any person, being the spouse or civil partner of any existing Adult or Senior member, residing at the same address as that existing member. Family Membership may also be granted to minor children of an existing Adult or Senior member, regardless of residence.
- 1.4 Overseas/Country Membership may be granted to any person having their permanent residence more than 50 miles from the Clubhouse.
- 1.5 Social membership may be granted to any person not holding a golf season ticket issued by Carnoustie Golf Links Management Committee Limited.
- 1.6 All members joining the Club shall be deemed to accept the terms of the Club Constitution and any alterations or amendments from time to time adopted by the Club in particular including the requirement to conduct themselves in accordance with any conduct rules, equity policy and disciplinary procedures.
- 1.7 The Club shall include within its Standing Orders/Byelaws the process for any person seeking membership of the Club. This process shall reflect that membership is open to all and no application shall be refused on grounds of gender, gender reassignment, age, race, religion or belief, sexual orientation, marriage and civil partnership, pregnancy and maternity or disability.
- 1.8 Annual subscriptions shall be due on 1st February in each year and must be paid by 1st March, failing which the resignation of the member concerned may be assumed.
- 1.9 On issuing notices of subscription due, the Club shall provide details of the amount payable, the due date for payment and the methods of payment available to members.

The granting of membership is at the sole discretion of the Ordinary and/or Council Members present and voting at the meeting before which the Application is laid, and the Club will be under no obligation to provide reason or explanation for any application which is not so granted.
